









4th Workshop on "Migration, Globalization and the Knowledge Economy" May 17-18, Online-Bordeaux-Madrid

Presentation

The workshop is part of a series of 5, first launched in 2018, on the topic of migration and its relationship with knowledge creation, diffusion, entrepreneurship, international business, innovation, and move innovation-related issues. Like the previous ones, it is a joint scientific initiative of CEPII, EPFL, PSE, Utrecht, ICRIOS-Bocconi, GSSI, IPP-CSIC, and GREThA-Université de Bordeaux. Locally, it is jointly organized by the Associated Laboratory on Linkages between Innovation and Environmental Sustainability (ALLIES - https://irp-allies.com/), the Research Group in Theoretical and Applied Economics (GREThA - https://gretha.cnrs.fr/) at the University of Bordeaux and the Institute of Public Goods and Policies (IPP) at the Spanish National Research Council (CSIC - http://ipp.csic.es/en).

Keynote speakers

Jennifer Hunt

Jennifer Hunt is Professor of Economics at Rutgers University, where she holds the James Cullen Chair in Economics. She is also a Research Associate at the National Bureau of Economic Research in Cambridge, Massachusetts, a Research Fellow at the Centre for Economic Policy Research in London, and is on the Scientific Advisory Council of the Institut für Arbeitsmarkt- und Berufsforschung in Nuremburg. She previously served as Deputy Assistant Secretary for Microeconomic Analysis at the U.S. Department of the Treasury after serving a term as Chief Economist to the U.S. Secretary of Labor, serving under Acting Secretary Seth Harris and Secretary Thomas Perez. Her research interests range from employment and unemployment policy, immigration to wage inequality, transition economics, crime and corruption. As of recent, she has worked on immigration and innovation in the United States, the U.S. science and engineering workforce, and the 2008-2009 recession in Germany. Her research on immigration has been cited by media in the context of immigration reform legislation, currently under consideration by the U.S. Congress.



































Fabian Waldinger

Fabian Waldinger is Professor of Economics at the Institute for the Economics of Innovation of the Ludwig Maximilian University in Munich. He previously held positions at the London School of Economics and the University of Warwick. His research interests include the economics of science and innovation, economic history, and labour economics. In particular, he combines the collection of large data sets, often from archival sources, with the use of modern micro-econometric techniques to understand the driving forces of scientific productivity and the production and allocation of talent. His research has been published in leading economics journals such as the American Economic Review, the Quarterly Journal of Economics, the Journal of Political Economy, and the Review of Economic Studies. He has won a number of awards for his research, including a Starting Grant from the European Research Council (ERC) and the Philip Leverhulme Prize in 2016.
